## II. Annotations to the provisional agenda

### 1. Organizational matters

#### *Venue and opening of the session*

1. Pursuant to provisions contained in decision 34/COP.15 and subsequent consultations with the Government of Mongolia, the seventeenth session of the Conference of the Parties (COP 17) will be held in Ulaanbaatar from 17 to 28 August 2026.

2. COP 17 will be formally opened by the President of COP 16 on 17 August.

#### (a) Election of the President

3. The President of COP 16 will propose the election of the President of COP 17.

#### (b) Adoption of the agenda

4. *Background:* In accordance with decision 36/COP.16 and other relevant decisions, the secretariat has prepared a provisional annotated agenda for COP 17 (ICCD/COP(17)/1), as well as other documents needed for its deliberations.

5. *Action:* The Conference of the Parties (COP) will be invited to adopt its agenda and schedule of work for the session.

#### (c) Election of officers other than the President

##### (i) Election of Vice-Presidents

6. *Background:* Decisions 1/COP.1 and 20/COP.2 (rule 22 of the rules of procedure).

7. *Action:* The COP will be invited to elect nine Vice-Presidents from among the representatives of the Parties present at the session. This election will take place at the opening meeting of the COP on 17 August.

##### (ii) Election of the Chair of the Committee on Science and Technology

8. *Background:* Rule 22 and rule 31 of the rules of procedure (as amended by decision 25/COP.10).

9. *Action:* The COP will be invited to complete its consultations and elect the Chair of the Committee on Science and Technology (CST) at the final meeting of COP 17.

##### (iii) Election of the Chair of the Committee for the Review of the Implementation of the Convention

10. *Background:* Rule 31 of the rules of procedure (as amended by decision 25/COP.10) and decision 13/COP.13, paragraph 7.

11. *Action:* The COP will be invited to complete its consultations and elect the Chair of the Committee for the Review of the Implementation of the Convention (CRIC) at the final meeting of COP 17.

#### (d) Credentials of delegations

12. *Background:* In accordance with rules 19 and 20 of the rules of procedure, the COP Bureau will examine the credentials of representatives, alternate representatives and advisers and submit its report to the COP for decision. The report on credentials will be contained in document [ICCD/COP\(17\)/13](#).<sup>1</sup>

13. *Action:* The COP will be invited to consider the report of its Bureau and adopt a decision on this matter.

**(e) Accreditation of intergovernmental organizations, civil society organizations and representatives from the private sector, and admission of observers**

14. *Background:* In accordance with the provisions of article 22, paragraph 7, of the Convention, of rules 6 and 7 of the rules of procedure, and of decision 26/COP.1, a list of intergovernmental organizations and civil society organizations (CSOs), including non-governmental organizations proposed for accreditation at COP 16, is contained in document [ICCD/COP\(17\)/INF.6](#). By its decision 5/COP.10, the COP adopted revised procedures for the accreditation of CSOs and representatives from the private sector to the COP and their participation in meetings and processes of the United Nations Convention to Combat Desertification (UNCCD).

15. *Action:* The COP will be invited to consider this matter and agree to accredit as observers the organizations and entities listed in document [ICCD/COP\(17\)/INF.6](#).

**(f) Organization of work, including the sessions of the subsidiary bodies**

*Establishment of a Committee of the Whole and allocation of its tasks*

16. *Background:* The practice followed at previous sessions of the COP, in line with rule 28.1 of the rules of procedure, has been to establish at the opening plenary meeting a sessional Committee of the Whole (COW) open to the participation of all Parties. The COP may wish to follow the same practice at COP 17. The COW will recommend draft decisions for adoption by the COP. Its Chair will have the authority to delegate work, as appropriate, to drafting groups. The COP may allocate the following items to the COW:

- (a) 2018–2030 Strategic Framework of the United Nations Convention to Combat Desertification:
  - (i) Enhancing the implementation of the Convention and its 2018–2030 Strategic Framework of the United Nations Convention to Combat Desertification;
  - (ii) Review of progress in the implementation of the United Nations Convention to Combat Desertification communication plan;
- (b) Final report of the Intergovernmental Working Group on the Future Strategic Framework of the Convention;
- (c) Promotion and strengthening of relationships with other relevant conventions and international organizations, institutions and agencies;
- (d) Policy frameworks and thematic issues;
- (e) Programme and budget for the biennium 2027–2028;
- (f) Procedural matters:
  - (i) Participation and involvement of civil society organizations in meetings and processes of the United Nations Convention to Combat Desertification;

- (ii) Participation and involvement of the private sector in meetings and processes of the United Nations Convention to Combat Desertification and the business engagement strategy;
  - (iii) Programme of work for the eighteenth session of the Conference of the Parties;
- (h) Any other matters deemed to be appropriate.

17. By its decision 36/COP.16, paragraph 5, the COP requested the secretariat to circulate in all official languages at least six weeks prior to COP 17 one document for each governing body with all respective draft decisions prepared for Parties' consideration at the COP. Accordingly, document [ICCD/COP\(17\)/12](#) includes all substantive draft decisions proposed by the secretariat that will serve as a starting point for discussion and further negotiation in the COW contact groups.

18. *Action:* The COP will be invited to consider following the practice described in paragraph 16 above.

#### *Committee on Science and Technology*

19. The CST is tentatively scheduled to meet during the first week of COP 17 from 18 to 21 August. In accordance with decision 22/COP.16 and other relevant decisions, the secretariat has prepared a provisional agenda for the Committee's session ([ICCD/COP\(17\)/CST/1](#)), as well as other documents needed for its deliberations.

#### *Committee for the Review of the Implementation of the Convention*

20. The CRIC is tentatively scheduled to meet from 17 to 21 August during the first week of COP 17 and on 27 August during its second week. In accordance with decision 13/COP.13 and other relevant decisions, the secretariat has prepared a provisional agenda for the Committee's work ([ICCD/CRIC\(24\)/1](#)), as well as other documents for the session.

#### *High-level segment*

21. In accordance with decision 36/COP.16, a high-level segment, comprising a Heads of State Summit and ministerial dialogues, will be conducted during COP 17 from 23 to 26 August.

#### *Initial segment*

22. During the initial segment, from 17 to 21 August, in addition to the CST and CRIC sessions, the COW would initiate its work.

#### *Interactive dialogue sessions*

23. In accordance with the request of the COP in decision 5/COP.9 to ensure that the programme of work of the COP includes open dialogue sessions with the civil society in the first week of the COP, in order to ensure the effectiveness of its input in the deliberations of the COP, two half-day sessions have been planned for this purpose on 20 August in the morning and 24 August in the afternoon.

24. In accordance with decision 36/COP.16 and further to the request in decision 25/COP.16, paragraph 8, the Gender Caucus will be convened in the afternoon of 26 August as part of the official programme of work of the COP.

*Concluding segment*

25. During the concluding segment from 27 to 28 August, the COP will consider all decisions not previously adopted.

26. The COP will also decide the date and venue of the twenty-fifth session of the CRIC, taking into account decision 13/COP.13 on the terms of reference of the CRIC, its operations and its schedule of meetings, and any further decision on the matter taken during the current session.

27. The tentative schedule of work for COP 17 (see annex I) allows for the concluding plenary meeting on 28 August. Accordingly, all negotiations should be concluded by 27 August.

*Times of meetings*

28. The integrated tentative schedule of work for COP 17 (see annex II) aims to make best use of the facilities available during normal working hours of the session (from 10:00 to 13:00 and from 15:00 to 18:00). Some special events are foreseen to take place throughout the COP session at lunch time (from 13:00 to 15:00).

## **2. 2018–2030 Strategic Framework of the United Nations Convention to Combat Desertification**

### **(a) Report of the Committee for the Review of the Implementation of the Convention and its recommendations to the Conference of the Parties**

29. *Background:* By its decision 13/COP.13, the COP decided to renew the mandate of the CRIC as a standing subsidiary body of the COP to assist it in regularly reviewing the implementation of the Convention and the 2018–2030 Strategic Framework of the United Nations Convention to Combat Desertification (UNCCD 2018–2030 Strategic Framework). In the same decision, the COP adopted the terms of reference of the CRIC, which, inter alia, define the mandate and functions of the CRIC.

30. Pursuant to article 22, paragraph 2 (d), of the Convention, the COP will review reports submitted by its subsidiary bodies and provide guidance to them. In accordance with decision 13/COP.13, the CRIC shall report regularly to the COP on all aspects of its work and in particular through draft decisions prepared at sessions held in conjunction with ordinary sessions of the COP, where necessary, for consideration and adoption by the COP.

31. *Action:* The COP will be invited at its plenary meeting on 27 August to consider the report of the twenty-fourth session of the CRIC and to adopt decisions as appropriate.

### **(b) Enhancing the implementation of the Convention and its 2018–2030 Strategic Framework of the United Nations Convention to Combat Desertification**

32. *Background:* By its decision 7/COP.16, the COP requested the Executive Secretary to support the capacity of national focal points (NFPs) and science and technology correspondents (STCs) to enhance national information-sharing and coordination on UNCCD matters and to translate the land degradation neutrality (LDN) concept and methodology into a concrete tool and support the development of transformative projects to address desertification, land degradation and drought (DLDD). The COP further requested the Executive Secretary to consult with Parties categorized as non-affected on how best to integrate their national circumstances within the UNCCD process and participate in the next

UNCCD reporting cycles. Furthermore, the Executive Secretary was requested to initiate an overall comprehensive discussion among Parties on how to best to reaffirm the global role and importance of the UNCCD in deepening political commitment and cooperation to address DLDD.

33. The same decision requested the secretariat to prepare recommendations for the NFPs and STCs to assist in national efforts to effectively coordinate and share information concerning the Convention at the national and local levels with a view to supporting its implementation.

34. In paragraph 7 of the same decision, the COP requested the secretariat and the Global Mechanism (GM) to collaborate with Parties, the private sector and partners on the development and improvement of best practices and guidelines that are relevant to addressing DLDD. Furthermore, in paragraph 22 of that decision, the same were requested to further focus on large-scale, high-impact, multi-country flagship initiatives, projects and programmes and scale up the GM's capacity-building to countries and relevant stakeholders to help in accessing funding from a variety of sources. The COP finally requested the two entities to strengthen the transparency of the monitoring and reporting mechanisms to track the progress of resource mobilization efforts and the implementation of large-scale projects.

35. The COP requested the secretariat to report on the implementation of decision 7/COP.16 at COP 17. This report is contained in document [ICCD/COP\(17\)/5](#).

36. *Action:* The COP is invited to consider the relevant document and take any further action, as appropriate.

**(c) Review of the report of the Committee on Science and Technology and its recommendations to the Conference of the Parties**

37. *Background:* By its decision 9/COP.1, the COP decided that the review, pursuant to article 22, paragraph 2 (d) of the Convention, of the report of the CST, including its recommendations to the COP and its programme of work, and the provision of guidance to it, would be a standing item on its agenda.

38. The CST will transmit to the COP draft decisions resulting from the deliberations coming from the items included in the agenda of its seventeenth session, in line with decision 22/COP.16 and other relevant decisions.

39. In paragraph 8 of decision 20/COP.16 on the future functioning of the Science-Policy Interface, COP decided to include in the agenda of each intersessional meeting of the CRIC an item for the consideration of priorities for science–policy guidance. At the final plenary meeting of CRIC 23 on 5 December 2025, the CRIC decided, in line with rule 13 of the rules of procedures of the COP, to defer consideration of item 5 “Consideration of priorities for science–policy guidance” of the CRIC 23 agenda and corresponding issued document ([ICCD/CRIC\(23\)/7](#)) to COP 17 for further consideration and action by Parties.

40. *Action:* The COP will be invited to consider allocating the deferred CRIC 23 agenda item 5 “Consideration of priorities for science–policy guidance” and the corresponding CRIC 23 document to CST 17. Also, the COP will be invited to consider the CST 17 report and adopt decisions as appropriate.

**(d) Review of progress in the implementation of the United Nations Convention to Combat Desertification communication plan**

41. *Background:* At the meeting of the COP Bureau on 24 February 2026, Germany, on behalf of the European Union and its Member States, requested, in accordance with rule 10, paragraph (e), of the rules of procedure of the COP, the inclusion of the review of the progress in the implementation of the UNCCD communication plan as an item on the COP 17 agenda.

42. *Action:* The COP will be invited to consider the information on the status of implementation of the UNCCD communication plan as referred to in document [ICCD/COP\(17\)/CRP.1](#) and take further actions, as appropriate.

**3. Final report of the Intergovernmental Working Group on the Future Strategic Framework of the Convention**

43. *Background:* By decision 4/COP.16, the COP established an Intergovernmental Working Group on the Future Strategic Framework of the Convention (IWG-FSF) to identify key elements for a post-2030 strategic framework of the UNCCD and conduct a thorough analysis of current indicators for national reporting on the strategic objectives of the 2018–2030 UNCCD Strategic Framework with a view to making them more responsive for a post-2030 strategic framework of the Convention.

44. In paragraph 14 (a) of the same decision, the COP requested the IWG-FSF to present an interim report for consultation to Parties, intergovernmental organizations and regional groups at CRIC 23. At the final plenary meeting of CRIC 23, the CRIC decided, in line with rule 13 of the rules of procedures of the COP, to defer consideration of item 4 “Interim report of the Intergovernmental Working Group on the Future Strategic Framework” of the CRIC 23 agenda and corresponding issued documentation ([ICCD/CRIC\(23\)/4](#) and its [Add.1](#)) to COP 17 for further consideration and action by Parties.

45. Furthermore, in paragraph 14 (b) of the same decision, the COP requested the IWG-FSF to present its final report at COP 17.

46. *Action:* The COP will be invited to consider allocating the deferred CRIC 23 agenda item 4 “Interim report of the Intergovernmental Working Group on the Future Strategic Framework” and corresponding CRIC 23 documentation to the COW. Also, the COP will be invited to consider the final IWG-FSF report, as included in document [ICCD/COP\(17\)/2](#), and the related draft decision and take any further action, as appropriate.

**4. Promotion and strengthening of relationships with other relevant conventions and international organizations, institutions and agencies**

47. *Background:* By its decision 8/COP.16, paragraph 6, the COP requested the secretariat, subject to the availability of resources, to promote the sharing of data collected under each convention, initiate joint science–policy publications, improve countries’ access

to case studies and lessons learned, consider building the interoperability of information management systems, and promote workshops and awareness-raising efforts for synergies.

48. Also, in paragraph 7 of the same decision, the COP requested the secretariat and appropriate Convention bodies and institutions, within their respective mandates and existing resources, to: (a) continue to strengthen existing and seek new partnerships that enhance the implementation of the Convention, address DLDD, and help achieve voluntary LDN targets; (b) continue to strengthen collaboration with relevant United Nations entities and other partners to provide best practices and practical tools, technical guidance and capacity-building related to the implementation of UNCCD policy frameworks; (c) develop and implement, in partnership with relevant organizations and networks, stakeholder engagement plans, including awareness-raising strategies, for policymakers in the public sector, as well as relevant stakeholders; and (d) continue to intensify efforts to strengthen the interlinking of the scientific bodies associated with the Rio conventions and with other relevant data-providing initiatives in order to create the scientific basis for joint target achievement across the conventions.

49. The COP requested the secretariat to report to the COP at its seventeenth session on the implementation of decision 8/COP.16. This information is contained in document [ICCD/COP\(17\)/6](#).

50. *Action:* The COP will be invited to consider the relevant document and draft decision and take any further action, as appropriate.

## 5. Policy frameworks and thematic issues

### *Migration*

51. *Background:* In paragraph 2 of decision 23/COP.16, the COP requested the GM to: (a) continue supporting resource mobilization for integrated initiatives that address the impacts of DLDD as one of the drivers of migration in order to provide economic opportunities for youth and livelihoods for people in vulnerable situations, and support the empowerment of Indigenous Peoples, local communities, women, and people with disabilities; and (b) continue assessing and supporting country Parties to implement recommendations and facilitate resource mobilization to leverage expatriate communities and new private sources of investment for desertification, land degradation, land restoration, and drought resilience projects and programmes.

52. In addition, in paragraph 3 of the same decision, the COP requested the secretariat, subject to the availability of resources, to: (a) assist Parties, upon request, in strengthening urban–rural linkages to achieve voluntary LDN targets and enhance the implementation of the Convention; (b) continue to support subregional, regional and international cooperation and initiatives that aim to promote sustainable land and water management and drought resilience as a means to help mitigate one of the drivers of forced migration and displacement; (c) continue to strengthen cooperation with other United Nations agencies and programmes, regional and international organizations, and other stakeholders to support initiatives on the matter, and collaborate and share information to foster a better understanding of urban–rural linkages, with a special focus on achieving LDN and drought resilience; and (d) support the scaling up and dissemination of good practices on sustainable land and water management and drought resilience, including through training and capacity-building, identified at the local and subnational levels.

53. The COP requested the secretariat and the GM to report to the COP at its seventeenth session on progress made in implementing decision 23/COP.16. This information is contained in document [ICCD/COP\(17\)/8](#).

54. *Action:* The COP will be invited to consider the relevant document and draft decision and take any further action, as appropriate.

#### *Drought*

55. The COP requested the secretariat to report to the COP on the implementation of decision 23/COP.15 at future sessions of the COP.

56. By its decision 24/COP.16, the COP took note of the report of the Intergovernmental Working Group on Drought, as included in document [ICCD/COP\(16\)/20](#), and the options contained therein. The COP decided to continue discussions on the basis of the progress made at COP 16 in Riyadh, as contained in the annex to that decision, with a view to adopting a decision in this regard at COP 17.

57. *Action:* The COP will be invited to consider the relevant documents and draft decisions and take any further action, as appropriate.

#### *Gender*

58. By its decision 25/COP.16, paragraph 4, the COP requested the secretariat and relevant bodies of the Convention, within their respective mandates, and in collaboration with other relevant conventions and international organizations, institutions and agencies, as appropriate, and subject to availability of funding, to develop effective and meaningful gender-specific indicators for (i) the future Strategic Framework of the United Nations Convention to Combat Desertification, and (ii) the monitoring and reporting process associated with the next Strategic Framework;

59. In paragraph 5 of the same decision, the COP requested the secretariat and the GM to identify and apply, according to the rules of procedure of the United Nations Convention to Combat Desertification, means of further facilitating the capacity-building and effective participation of women delegates, as appropriate, including from Indigenous Peoples, local communities, and CSOs, for the purpose of increasing the number of women delegates attending and effectively participating in the UNCCD sessions.

60. The COP requested the secretariat to report on the progress made in implementing decision 25/COP.16 at its seventeenth session.

61. *Action:* The COP will be invited to consider the relevant document and draft decision and take any further action, as appropriate.

62. By its decision 27/COP.16, paragraph 4, the COP requested the secretariat and the GM, in matters pertaining to the Convention, and subject to the availability of resources, to continue: (a) actively participating in the United Nations Coalition on Combating Sand and Dust Storms to, among other things, develop a global implementation initiative on sand and dust storms (SDS) to define and address, in particular, anthropogenic SDS sources and data information gaps as well as engage in advocacy, awareness-raising and other activities for the United Nations Decade on Combating Sand and Dust Storms (2025–2034); (b) promoting and refining the Sand and Dust Storms Toolbox and other geographic information system platforms, data and tools and supporting the capacity of country Parties to use these resources; (c) developing a comprehensive inventory of existing SDS-related tools, technologies, and best practice guidelines; and (d) supporting countries, regions and subregions to develop SDS strategies and action plans as well as implement and finance SDS-related projects and programmes;

63. The COP requested the secretariat and the GM to present at COP 17 a report on policy issues relevant to decision 27/COP.16.

64. *Action:* The COP will be invited to consider the relevant document and draft decision and take any further action, as appropriate.

66. In paragraph 10 of decision 28/COP.16, the COP requested the secretariat and the GM to carry out awareness-raising actions on their existing accountability and grievance mechanisms related to land tenure to have the widest reach among all stakeholders concerned by their activities in order to combat DLDD and achieve LDN.

67. The COP requested the secretariat to prepare a report for COP 17 on policy issues relevant to decision 28/COP.16.

68. *Action:* The COP will be invited to consider the relevant document and draft decision and take any further action, as appropriate.

69. *Background:* By its decision 29/COP.16, the COP requested the secretariat and the GM to: (a) strengthen and contribute to public–private partnerships with a view to implementing transformative projects and programmes that engage with relevant stakeholders and ongoing initiatives that support rangeland health and pastoralist resilience; (b) support Parties with awareness-raising, capacity-building and resource mobilization

through inclusive, community-based and participatory approaches that meaningfully engage pastoralist and other rangeland communities, including Indigenous Peoples and local communities; and (c) contribute to the development of initiatives for sustainable rangeland management, restoration and conservation through, inter alia, multi-stakeholder dialogues and national consultations.

70. The COP requested the secretariat to report on progress made in implementing decision 29/COP.16 at its seventeenth session.

71. *Action:* The COP will be invited to consider the relevant document and draft decision and take any further action, as appropriate.

## 6. High-level segment

### (a) Heads of State Summit

72. *Background:* In accordance with decision 36/COP.16, paragraph 2, a Heads of State Summit will be organized by the Government of Mongolia on 23 August.

### (b) Ministerial dialogues

73. The following ministerial dialogues will be organized from 24 to 26 August: (a) Innovative Financial Mechanisms for Healthy Land and Drought Resilience; (b) Accelerating Drought Resilience and (c) Restoration of Rangelands and Pastoralists' Communities;

74. Special events, including the Sustainable Land Management Business Forum (see decision 6/COP.16, para. 3 (h)), the Youth Forum, the Caucus for Indigenous Peoples and the Caucus for Local Communities (see decision 5/COP.16), will be organized on the sidelines of COP 17. Other special events focusing on topics such as innovative financing instruments, rangelands, SDS, and food systems and soil health will also take place during the thematic days from 24 to 27 August.

75. *Action:* The COP will be invited to consider the outcomes of the high-level segment and take any further action as appropriate.

## 7. Programme and budget for the biennium 2027–2028

76. *Background:* Article 22, paragraph 2 (g), of the Convention calls on the COP to approve a programme and budget for its activities, including those of its subsidiary bodies, and to undertake the necessary arrangements for their financing.

77. The COP, in paragraph 20 of decision 10/COP.16, requested the Executive Secretary to prepare an integrated, results-based budget and work programme for the biennium 2027–2028, presenting three budget scenarios and a work programme based on the projected needs for the biennium in (a) a zero nominal growth scenario; (b) a zero real growth scenario; and (c) a scenario based on further recommended adjustments to the first scenario and the added costs, and also report on any unspent balances.

78. In paragraph 21 of the same decision, the COP requested the Executive Secretary to carry out a review of the financial rules for the COP and to present a draft revised set of financial rules for consideration at COP 17.

79. *Action:* The COP will be invited to consider the proposed programme and budget for the biennium 2027–2028, the draft revised financial rules for the COP, and the corresponding draft decision and take further actions, as appropriate.

In decision 10/COP.16, paragraph 19, the COP requested the Executive Secretary to report to the COP at its seventeenth session on the status of income and expenditure and budget performance, using a results-based approach. Information on this matter is contained in document [ICCD/COP\(17\)/INF.3](#). The statement of accounts should be read in conjunction with document [ICCD/COP\(17\)/INF.4](#), which contains the report on the implementation of the costed 2025–2026 work programmes of the secretariat, the CRIC, the CST and the GM.

*Audited financial statements for the Convention trust funds*

81. In paragraph 23 of decision 10/COP.16, the COP requested the Executive Secretary to report on the implementation status of the latest audit reports at sessions of the COP. In line with decision 10/COP.15 paragraphs 25 and 26, the audited financial statements for the Convention trust funds may be consulted on the UNCCD website.<sup>2</sup>

## 8. Procedural matters

Furthermore, in paragraph 3 of the same decision, the secretariat was requested to facilitate the involvement of accredited CSOs in meetings and processes under the Convention and provide them with targeted capacity-building.

87. In paragraph 9 of the same decision, the COP requested the secretariat to facilitate consultations among Parties, UNCCD institutions and bodies, United Nations entities, and civil society, in particular Indigenous Peoples as well as local communities, prior to COP 17, on strengthening the participation of Indigenous Peoples as well as local communities in the UNCCD and to support the development of relevant terms of reference for the creation of a Caucus for Indigenous Peoples and a Caucus for Local Communities.

88. In paragraph 14 of the same decision, the COP requested the Civil Society Organization Panel, through the secretariat, to report at COP 17 on its activities.

89. Finally, the COP requested the secretariat to report at COP 17 on the implementation of decision 5/COP.16.

90. *Action:* The COP will be invited to consider the information contained in document [ICCD/COP\(17\)/3](#) and the corresponding draft decision and take any further action, as appropriate.

93. Furthermore, in paragraph 3 of the same decision, the COP requested the secretariat and the GM, within their respective mandates and subject to the availability of financial resources, and in collaboration with relevant financial and technical partners, to accelerate efforts to support private sector engagement and promote innovation.

94. The COP requested the secretariat to report to future COP sessions on the measures taken to facilitate and encourage the participation and involvement of the private sector in meetings and processes of the UNCCD.

95. *Action:* The COP will be invited to consider the information contained in document [ICCD/COP\(17\)/4](#) and the corresponding draft decision and take further actions, as appropriate.
