I. PARTICIPATION IN THE SECOND SESSION OF THE
CONFERENCE OF THE PARTIES

1. The following 93 affected developing countries were offered financing under the Special Voluntary Fund for participation in the second session of the Conference of the Parties; countries marked with an asterisk (*) are affected least developed countries for which two representatives were financed through the Special Voluntary Fund:

2. A representative of Palestine also received financing under the Special Voluntary Fund for participation in the second session of the Conference of the Parties.

3. In extending assistance to a total of 131 participants from the above-mentioned countries, an estimated amount of US\$ 523,000 inclusive of programme support costs was committed.

II. FURTHER CONTRIBUTIONS AND PLEDGES RECEIVED
