**I. PARTICIPATION IN THE THIRD SESSION OF THE  
CONFERENCE OF THE PARTIES**

1. Financing under the Special Fund was offered to 132 participants from the following affected developing countries for participation in the third session of the Conference of the Parties. Countries marked with an asterisk (\*) are the affected least developed countries for which two representatives were financed through the Special Fund:

2. In addition, in view of the discussions on the national reports submitted by African countries to the Conference of the Parties at its third session, two special contributions from France and Italy were received to facilitate a high level of representation by the countries concerned.

3. An estimated amount of \$974,000, inclusive of programme support, was therefore committed in order to offer support to a total of 165 participants.

## II. CONTRIBUTIONS AND PLEDGES RECEIVED

4. Tables 3 and 6 of document ICCD/COP(3)/3 list the contributions received and recorded for the Supplementary Fund and the Special Fund as of August 1999, reflecting the latest data available prior to submission of that document for processing and distribution.
