**SURVEY AND EVALUATION OF EXISTING NETWORKS, INSTITUTIONS,  
AGENCIES AND BODIES**

Note by the secretariat

1. In accordance with the provisions of paragraph 1 of article 25 of the United Nations Convention to Combat Desertification (UNCCD), the Committee on Science and Technology (CST) is to make provision for undertaking a survey and evaluation of relevant existing networks, institutions, agencies and bodies willing to become units of a network to support implementation of the Convention.
2. Pursuant to paragraph 3 of decision 13/COP.4, the Bureau of the Committee on Science and Technology at its inter-sessional meeting of 14-15 August 2001 invited the United Nations Environment Programme (UNEP) to submit a revised proposal for undertaking phase 2 of the survey and evaluation of existing networks, institutions, agencies and bodies.
3. In consultation with its Consortium partners, UNEP has revisited the original offer contained in ICCD/COP(4)/CST/3/Add.1 and suggests limiting the pilot phase 2 of the survey and evaluation to the 10 anglophone countries of the Southern African Development Community (SADC).
4. The submission from UNEP is annexed hereto as requested by the CST Bureau.

REVISED PROJECT PROPOSAL

**Title of project: *Phase 2 of the survey and evaluation of networks, agencies and bodies relevant to the implementation of the Convention: Pilot in-depth survey in the southern African subregion and maintenance and development of the database developed during phase 1***

With reference to the request by the Bureau of the Committee on Science and Technology at its meeting on 14-15 August 2001 (ref. ICCD/COP(5)/INF.6 of 21 August 2001), the UNEP-led Consortium of agencies submits herewith its revised proposal for undertaking phase 2 of the Survey and evaluation of networks, agencies and bodies relevant to the implementation of the Convention (ref. the original offer ICCD/COP(4)/CST/3/Add.1 of 29 November 2000).

By concentrating exclusively on anglophone countries during the phase 2 pilot project, Consortium members will be able to work with a broad range of southern African countries in the most cost-effective way possible.

Developing, testing and refining the in-depth survey instruments in one language alone will enable the Consortium to cut down as much as possible on potential problems of misunderstanding or mistranslation during phase 2, and to concentrate entirely on developing the best possible survey instruments for wide-scale use during phase 3. Once the in-depth survey instruments are fully developed and tested in one language, it will be a much quicker and more cost-effective task to translate these instruments into other languages for use during phase 3.

However, further development of the web site/database language capabilities will continue as per the original plan for phase 2.

Since its inception during phase 1, the web site database has allowed data entry in European languages based on Roman script (such as English, French, German, Spanish and Portuguese); this will continue to be true during phase 2. In addition, during phase 2 the database development team will work to ensure better search capabilities across all these European languages, so that, for example, a search by country name or key word in Spanish will not only retrieve all relevant entries for that term in Spanish-language entries, but will also retrieve relevant entries for that term in other European languages.

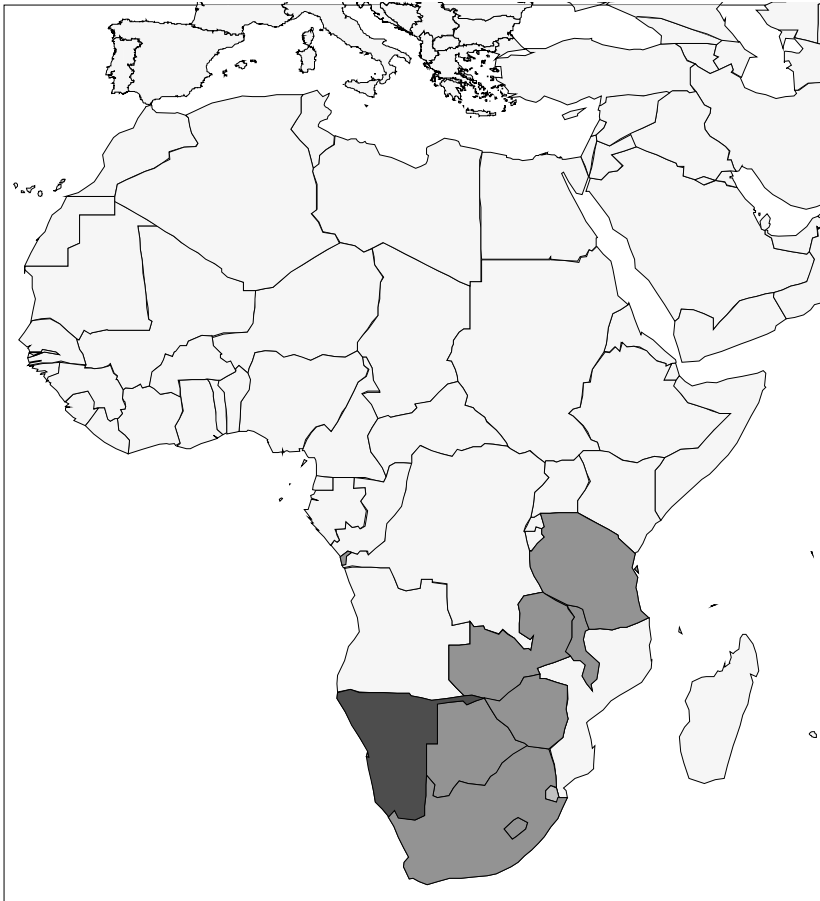


Figure 1: The 10 anglophone member states of the Southern African Development Community (SADC): Botswana, Lesotho, Malawi, Mauritius, Namibia, South Africa, Swaziland, Tanzania, Zambia and Zimbabwe.

By limiting the pilot survey to the 10 anglophone countries of SADC (ref. figure 1 below), instead of the original 18 anglophone, francophone and Portuguese-speaking countries of the southern African subregion, the Consortium would also be able to bring the cost of the project down to US\$ 440,000 from the original US\$ 655,000. This is due mainly to less costly workshops with fewer participants and no translation and interpretation requirements, fewer country visits and fewer country Parties to be supported. The attached revised budget sheet gives the new breakdown of costs by activity clusters and by members of the Consortium.

The proposed concentration of the phase 2 project would not otherwise affect the level of planned activities and outputs or the envisaged support to Parties.

The other terms and conditions of the original offer (ICCD/COP(4)/CST/3/Add.1 of 29 November 2000) remain valid.
