## TERMS OF REFERENCE

### International Consultant to support SADC GGWI

**Consultancy reference number: CCD/23/C/63 (re-advertisement)**

**(Those who have applied before do not need to apply again)**

#### Background

The Global Mechanism (GM) is an institution of the UNCCD, mandated to assist countries in the mobilization of financial resources from the public and private sector for activities that prevent, control or reverse desertification, land degradation and drought. As the operational arm of the convention, the GM supports countries to translate the Convention into action. The GM is currently spearheading several initiatives to implement its resource mobilization mandate by supporting countries in the development of a pipeline of projects and programmes for financing by donors and partners. We are also promoting multi-sector, multi-stakeholder approaches to facilitate the financing and implementation of projects contributing to synergies across the objectives of the three Rio Conventions.

A number of important flagship initiatives have emerged globally that showcase the potential impact of large scale efforts to conserve, sustainably manage and restore land.

The African-led Great Green Wall Initiative (GGWI) aims to restore the continent's degraded landscapes and transform millions of lives by tackling the triple challenges of desertification, climate change and loss of biodiversity. Inspired by the Great Green Wall Initiative of the Sahel, the Southern African Development Community Secretariat (SADC) and the African Union Commission launched the SADC GGWI.

In this context, the GM of the UNCCD in collaboration with the SADC Secretariat the AUC, AUDA-NEPAD and the Commonwealth Secretariat and other partners are supporting implementation of the SADC GGWI initiative in 16 countries and across multiple investment pillars and complex cross cutting themes. The SADC GGWI will provide an multisectoral platform for planning and collaboration to bring new investment and revenue to the Region. The scale and impact of the SADC GGWI is expected to grow exponentially and gain prominence in the coming years as the resource mobilization and political engagement roadmap is delivered.

#### Objective of consultancy

The expected outputs from the consultant include:

- Parties and critical stakeholders are fully informed about the challenges, opportunities, ongoing projects and implementation gaps to be filled in the Region.
- There is a coordinated approach to advocacy, awareness raising and resource mobilization and a common understanding of the goals and indicators of success.
- A pipeline of projects and programmes, under the SADC GGWI and aligned with requirements of identified funding sources, is developed.

#### Duties and Responsibilities

Under the overall supervision of the Managing Director of the Global Mechanism and direct supervision of the LDN and Land Restoration Programme Coordinator and assigned officer, the consultant will be supporting in the operationalization of the SADC GGWI.

Duties will be carried out in close collaboration with the SADC Secretariat, the African Union Commission, other partners and country Parties.

The consultant will be responsible for the following critical duties:



- Writing a situational analysis (key physical features, socio-economic data etc) for the region and identification of the key issues that the initiative will be designed to address
- Mapping of the donor landscape in the region.
- Mapping of relevant partners (financial, technical) and key stakeholders (focal points for financing)
- Mapping of relevant projects, programmes and initiatives that are complete/under implementation/under development (since 2019), and that contribute to the investment pillars and cross-cutting issues with the aim of developing a base map and to inform the development of new projects and programmes that will fill implementation gaps.
- Establishing criteria for projects and programmes to be considered as falling under the SADC GGWI.
- Supporting consultations on the development of theory of change and harmonized results framework (including core targets and critical indicators under each of the GGWI investment pillars and cross-cutting issues).
- Supporting the organization of a series of events to consult with Parties and stakeholders on key decision and documents or for policy advocacy, awareness-raising and resource mobilisation.
- Leading project preparation and supporting resource mobilization to develop a portfolio of investment-ready project and/or programme concept notes and proposals. The projects and programmes will be developed in close collaboration with partners and country representatives.

### **Deliverables**

---

The expected deliverables from the consultant include:

1. Workplan with key milestones upon inception meeting with the GM team.
2. Financing landscape.
3. Partner and stakeholder map/database.
4. A base map of projects and programmes that are complete/under implementation/under development (since 2019), and that contribute to the investment pillars and cross-cutting issues.
5. Validation/consultation workshops organized to consider:
  - Criteria and a format for future submissions to a pipeline of projects and programmes, under the SADC GGWI.
  - A theory of change and draft harmonized results framework.
6. Reports of three events/meetings organized on policy advocacy, awareness-raising and/or validation/consultation.
7. Project/programme documents (the documents needed depend on the targeted funding and may include pre-concept notes, concept notes, project proposals, project identification forms, feasibility studies, among others). *Total number of project/programme documents will depend on level of effort to be agreed in advance.*

### **Contractual terms**

---

The service of the selected consultant is estimated to be for a period of 12 months. The consultant will be paid on a monthly basis upon the submission of timesheets. The consultancy is home based. Where travel is deemed relevant and necessary, for example to organize meetings or events, it will be organized and funded separately by the UNCCD or a partner organization of the GGWI.



All products resulting from this contractual arrangement are the exclusive property of the UNCCD.

### Requirements

---

- ✓ Advanced university degree in climate/development finance, environmental science, agriculture, forestry, climate change, soil sciences, environmental economics, renewable energy, business development and management, public policy or related fields;
- ✓ A minimum of ten years of experience in project preparation, climate and /or development finance and resource mobilization in at least one of the thematic areas of the SADC GGWI investment pillars and cross-cutting issues for multilateral developments banks, bilateral donors, private sector investors, or for financing institutions such as the Global Environment Facility, Green Climate Fund or Adaptation Fund;
- ✓ Knowledge and understanding of SADC processes and frameworks relevant to the SADC GGWI investment pillars and cross-cutting issues;
- ✓ Experience in responding to Calls for Proposals and Expressions of Interest
- ✓ Experience in developing project budgets, project/programme coordination and monitoring and evaluation;
- ✓ Experience organizing events and meetings for policy advocacy, awareness-raising or consultation;
- ✓ Experience working on advancing gender equality and social inclusion in projects and programmes is a strong asset;
- ✓ Experience engaging with private sector stakeholders is an asset.

### Special notice

---

Only individuals who can act as independent, individual economical operators are qualified to apply. Individuals who can provide their services only on account of an institution or enterprise not in their individual capacity are not eligible under this procedure.
